Welcome, Introductions, Approval of Minutes, Agency Announcements

The meeting was brought to order. Martha Chadburn made a motion to accept the minutes from the August 9, 2016 Tobacco Free Partnership meeting with no changes. The motion was seconded by Cindy Austin. The minutes were approved unanimously by a voice vote from members in attendance.

Members introduced themselves, including a new member, Lorrie van Voorthuijsen from the Hanley Center in Citrus County. The Hanley Center Foundation is based in West Palm and they have received a federal grant that covers Citrus and Levy Counties. She announced to the group that they are hosting a 90-minute "Alcohol Literacy Challenge" in Levy County schools as well as Active Parenting and Active Parenting Teens Programs in the community. The Active Parenting program is a 6-week program lasting two hours each week, for parents of children ages zero to twelve. The Active Parenting Teens program is for parents of teenagers ages twelve to eighteen. They are currently looking for groups of parents to attend the programs – they would like at least six parents to sign up before they can commit to hosting the programs.

Jodian Blake from Suwannee River Area Health Education Center announced upcoming Quit Your Way tobacco cessation classes in Levy County and shared flyers with attendees. The class will take place on October 22nd and November 19th at the Regional General Hospital in Williston. These classes offer free nicotine replacement gum, patches, and/or lozenges to participants. Jodian also mentioned that Suwannee River AHEC is now hiring a Health Insurance Navigator for the Tri-County area to work 24-hours a week.

Rose Wilder from the Levy County Prevention Coalition updated the group that they have partnered up with the Sheriff's Office to host a prescription drug drop-off day on October 22nd from 10am-2pm. People who have unwanted or unused prescription drugs can safely dispose of them at the Sheriff's Office.

Kyle Roberts from the Florida Department of Health Levy, Dixie, Gilchrist Counties updated the group that they hosted a five-mile run event for Levy County that coincided with the Peanut Festival in Williston on October 1st. He reported that 102 people attended the event for Levy County.

Martha Chadburn announced that the College of Central Florida has decided not to host a Great American Smoke Out Health Fair this year, and instead will host a presentation and information session for the Adult Education Class and CF staff on November 15th to celebrate GASO and encourage people to make a cessation attempt.

Jaime Hinote from Palms Medical Group updated the partnership that they are hosting a Fall Festival for kids on October 22nd at the Chiefland Clinic from 4pm-7pm. The event is free and open to the public and there will be a costume contest for children as well as games, face painting, bounce houses, and snacks. She shared a flyer for the event with the group.

Tobacco Prevention Program Updates

Kristina Zachry updated the partnership members that the Tobacco Prevention Program is still seeking SWAT advisors for Chiefland Middle School and Yankeetown School. Additionally, the Partnership participated with a booth at the Tri-County Baby Shower on September 20th and at the Cedar Key Seafood Festival on October 15th and 16th. The Seafood Festival was designated as a tobacco free event again this year with designated tobacco use areas away from the crowds. The Region 2 SWAT meeting is coming up on November 5th and Kristina will be chaperoning three youth, including Dakota Phillips, who intends to run for a position on the statewide Youth Advocacy Board. SWAT members in Levy Schools are planning their participation in Red Ribbon Week from October 21st to the 29th as well as the Great American Smoke Out on November 17th.
